It was decided each conference committee shall have One Senior Faculty Member as Mentor and an actively working faculty member as Coordinator, who will be assisted by the members of the Team.

It was decided to prepare the Brochure for the Conference by the first week of April, 2023.

Item No. 2: External Academic Audit - Planning & Execution

It was decided to conduct an Internal Academic Audit in the 2nd week of July 2023 and an External Academic Audit in the month of October 2023.

Vice Principal SFS-I suggested having a Programme/Wing-wise Audit instead of School wise.
