


### **EMPLOYER FEEDBACK**




### **Inference:**




### **Inference:**




### **Inference:**

A tiny portion (4.85%) of the employers only proposed the 'need improvement' scope of the curriculum in focusing on student-cantered learning.




### **Inference:**

A significant portion (41.74%) of employers graded 'good' on the curriculum, which consists of projects, dissertations, internships, and field visits that lead to real-life experiential learning. 10.67% of the employers expressed 'satisfactory' on projects, dissertations, internships, and field visits, which gives space for experiential learning. A very small proportion (3.88%) of the employers claimed they 'needed to' improve the curriculum, which includes projects, dissertations, internships, and field visits for experiential learning.




#### **Inference:**




### **Inference:**




### **Inference:**




### **Inference:**




#### **Inference:**
