Poly (aleuritic acid) homopolymer (PAA) was synthesized by ring opening polymerization of Erythro-9, 10- Benzyldenedioxyhexadecan-16-olide followed by deprotection. PAA self organize to form micelle depending on the nature of the solvents. The micelle structure PAA was found to be 108 nm in water and nontoxic. These micelles were loaded with Curcumin to fabricate nanoparticles and were characterized by DLS, TEM and AFM. The drug release kinetics was studied at three different pHs (5.8, 6.8 and 7.4) and the release pattern follows the combination of diffusion and erosion pathway. For the selected microorganisms, such as staphylococcus aureus, Salmonella typhimurium, Escherichia Coli and Bacillus cereus, the activity of curcumin nanoparticles was more pronounced against Gram-negative bacteria than Gram-positive bacteria. These nanoparticles were observed to promote wound closure by inducing proliferation and migration of the keratinocytes at the wound site and provided a hydrated surface necessary for cell proliferation.
